ON PONDEROSA AVE IN PASCO COUNTY, FLORIDA, THE DEFENDANT UNLAWFULLY OPERATED A MOTOR VEHICLE, 2002 DODGE SUV MAR IN COLOR BEARING FLORIDA TAG 1H0WU IN VIOLATION OF FLORIDA STATE STATUTE 316.193. DISPATCHER, FROM PASCO COUNTY, AND HER SPOUSE. THEY OBSERVED THE SUBJECT ATTEMPTING TO ENTER ANOTHER RESIDENCE (10970 PEPPERTREE LANE) AND STOPPED HER. THEY NOTIFIED ME AND I WENT TO THE LOCATION. UPON ARRIVAL I CONDUCTED A TRAFFIC CRASH INVESTIGATION, POST MIRANDA WARNINGS, I NOTICED A VERY STRONG ODOR OF AN ALCOHOLIC BEVERAGE OMMITING FROM HER BREATH AND THAT SHE HAD BLOODSHOT AND WATERY EYES, PLUS POOR BALANCE. AT THE CONCLUSION OF THE CRASH INVEATIGATION I INFORMED THE SUBJECT THAT I WAS GOING TO CONCLUDE MY TRAFFIC CRASH INVESTIGATION AND BEGAN A D.U.I. INVESTIGATION. THE DEFENDANT WAS GIVEN THE OPPORTUNITY TO PERFORM SOME FIELD SOBRIETY EVALUATIONS. THE DEFENDANT DID PERFORM THESE EVALUATIONS. AT THE CONCLUSION OF THESE EVALUATIONS. IT WAS DETERMINED THAT THE SUBJECT PERFORMED POORLY ON THESE EVALUTATIONS AND WAS LAWFULLY PLACED UNDER ARREST FOR DUI. THE DEFENDANT WAS ALSO INFORMED VERBALLY THAT SHE WAS BEING PLACED UNDER ARREST FOR DUI AND HIT AND RUN. THE DEFENDANT WAS QUESTIONED, POST MIRANDA, AS TO WHERE SHE HAD BEEN DRINKING AND WHEN DID SHE STOP. THE SUBJECT STATED SHE DID NOT KNOW WHERE SHE WAS DRINKING, BUT SHE HAD WAY TOO MANY AND THAT SHE HAD NOT BEEN DRINKING SINCE THE CRASH.

THE DEFENDANT WAS TRANSPORTED TO FHP DISTRICT OFFICE FOR AN APPROVED TEST OF HER BREATH TO DETERMINE HER BREATH ALCOHOL CONCENTRATION LEVELS. SHE WAS ADVISED OF FLORIDA'S IMPLIED CONSENT RULE AT 1:07 AM . AT WHICH TIME THE DEFENDANT DID CONSENT TO THE APPROVED TEST.

This will serve as notice of final order of license suspension effective on the date it was issued to you. You may request a formal review of the suspension as follows:

INFORMAL REVIEW

If you want the department to conduct an informal review of this suspension or disqualification, you must request such review of the location indicated on the reverse side. Your request must be submitted in writing within 10 calendar days following the date of suspension...

FORMAL REVIEW

If you want to be heard or present witnesses in regard to this suspension/disqualification, you must request a formal review at the location indicated on the reverse side. Your request must be submitted in writing within 10 calendar days following the date of suspension...

As a result of the informal or formal review hearing, the hearing officer shall determine by a preponderance of the evidence whether sufficient cause exists to revoke, amend, or invalidate the suspension/disqualification. The following issues will be considered at the hearing:

DRIVING WITH AN UNLAWFUL BLOOD OR BREATH ALCOHOL LEVEL (.08 OR ABOVE)

- 1. Whether the arresting law enforcement officer had probable cause to believe that the person was driving or in actual physical control of a motor vehicle in this state while under the influence of alcoholic beverage or controlled substance (DUI).
2. Whether the person had an unlawful blood or breath alcohol level (.08 or above).

The following issues will be considered at the review of a suspension for:

REFUSAL TO SUBMIT TO A BREATH, BLOOD OR URINE TEST

- 1. Same as number 1 above.
2. Whether the person refused to submit to any such test after being requested to do so by a law enforcement officer or correctional officer.
3. Whether the person was told that if he refused to submit to such test his privilege to operate a motor vehicle would be suspended.

IN CASE OF A DISQUALIFICATION FOR REFUSAL TO SUBMIT TO A BREATH, BLOOD OR URINE TEST, THE FOLLOWING ISSUES WILL BE CONSIDERED:

- 1. Whether the law enforcement officer had probable cause to believe that the person was driving or in actual physical control of a commercial motor vehicle in this state while he or she had any alcohol, chemical substance, or controlled substance in his or her body.
