67 EAST TROT TRAIL, LAKE WALES, FLORIDA AND IS _____'S PARAMOUR.

ON MAY 18, 2008 DURING A SWORN DIGITAL STATEMENT _____ STATED THAT SHE PLACED
HER SON, _____ IN THE CUSTODY AND CONTROL OF MICHAEL JOSEPH REID, JR. ON MAY 17 AT
APPROXIMATELY 2100 HOURS.

ALSO ADMITTED TO HAVING SEXUAL INTERCOURSE, (VAGINAL-PENILE) WITH MICHAL JOSEPH REID JR DURING THE PREVIOUS TWO MONTHS

ON MAY 19, 2008 DURING A POST, MIRANDA INTERVIEW AT THE BUREAU OF CRIMINAL INVESTIGATIONS REID JR PROVIDED THE FOLLOWED DOCUMENTED ACCOUNTS OF EVENTS.

REID JR STATED THAT AT APPROXIMATELY 0100 HOURS ON MAY 18, 2008 HE WAS WATCHING TELEVISION IN THE LIVING ROOM OF THE RESIDENCE LOCATED AT 3867 FAST TROT TRAIL. WAS LOCATED IN THE BEDROOM WHEN HE BEGAN TO CRY. REID STATED THAT HE RESPONDED INSIDE THE BEDROOM AND REMOVED HIM FROM HIS CRIB.

REID STATED THAT HE BEGAN FRUSTRATED AND UPSET BECAUSE [REDACTED] WOULD NOT STOP CRYING. REID JR STATED THAT HE GRABBED [REDACTED] AROUND THE WAIST AND, "SHOOK" HIM BACK AND FORTH IN AN ATTEMPT TO FORCE HIM TO STOP CRYING. REID JR STATED THAT WHEN THIS TECHNIQUE FAILED HE DROPPED [REDACTED] ONTO A PILLOW THAT WAS LYING ON THE BED WITHIN THE BEDROOM. REID STATED THAT [REDACTED] WAS QUITE FOR APPROXIMATELY ONE TO TWO SECONDS AFTER BEING DROPPED ONTO THE PILLOW THEN HE BEGAN CRYING AGAIN. REID JR STATED THAT HE WALKED OUTSIDE ON THE FRONT PORCH WITH [REDACTED]

REID JR STATED AS HE WAS WALKING OUTSIDE HE THREW [REDACTED]'S FACE AGAINST HIS LEFT SHOULDER. REID JR DEMONSTRATED THIS IN A FORCEFUL MANNER. REID JR STATED THAT AS HE WALKED AROUND THE CORNER OF THE RESIDENCE HE STUMBLED ON A HORSESHOE POST THAT HAD BEEN SECURED IN THE GROUND. REID JR STATED THAT HE FELL TO THE GROUND AS WELL AS [REDACTED]. REID JR STATED THAT HE GOT UP AND IMMEDIATELY THREW [REDACTED]'S FACE AGAINST HIS LEFT SHOULDER AGAIN. REID JR STATED HE CONTINUED TO BOUNCE [REDACTED] ON HIS SHOULDER. REID JR STATED THAT HE WALKED BACK AROUND TOWARD THE FRONT PORCH OF THE RESIDENCE. REID STATED THAT HE, "CUT" TO CLOSE TO THE PORCH AND SCRAPED [REDACTED]'S LEFT THIGH ON THE RAIL.

REID JR STATED ONCE INSIDE THE RESIDENCE HE WENT BACK INTO THEIR BEDROOM. REID JR STATED THAT HE COVERED [REDACTED]'S MOUTH WITH HIS HAND IN AN ATTEMPT TO STOP HIM FROM CRYING BUT THIS ATTEMPT ALSO FAILED. REID JR STATED THAT HE THEN GRABBED [REDACTED] UP AND, "HEAD BUTTED HIM". REID JR STATED THAT HE DID THIS SO FORCEFUL THAT IT CAUSED HIS OWN HEAD TO HURT.

REID JR STATED THAT AFTER HE HAD HEAD BUTTED [REDACTED] THAT HE STOPPED CRYING AND WENT TO SLEEP. REID JR STATED THAT AT APPROXIMATELY 0200 HOURS ON MAY 19 THE ONLY INJURY THAT HE FIRST OBSERVED ON [REDACTED] WAS A BRUISE SPOT ON HIS NOSE.

[REDACTED] ARRIVED HOME FROM WORK AT APPROXIMATELY 0900HOURS ON MAY 19, 2008 AT WHICH TIME SHE OBSERVED THE INJURIES TO [REDACTED]. AT THIS TIME, [REDACTED] WAS TRANSPORTED IN [REDACTED] PRIVATE VEHICLE TO THE LAKE WALES MEDICAL CENTER FOR EMERGENCY TREATMENT. ONCE AT LAKE WALES MEDICAL CENTER REID JR AGAIN FAILED TO ADVISE MEDICAL PERSONNEL HOW [REDACTED] HAD BEEN INJURED.

AT APPROXIMATELY 1600 HOURS, A DECISION WAS MADE BY MEDICAL PERSONNEL TO TRANSPORT [REDACTED] TO THE ARNOLD PALMER MEDICAL CENTER IN ORLANDO AND HE ARRIVED AT APPROXIMATELY 1700 HOURS ON MAY 19, 2008. UPON ARRIVAL OF REID JR. AT ARNOLD PALMER, HE AGAIN FAILED TO ADVISE MEDICAL PERSONNEL HOW [REDACTED] HAD BEEN INJURED.

ON ARRIVAL, [REDACTED] WAS EVALUATED AND THE PRELIMINARY FINDINGS INDICATE THE FOLLOWING INJURIES:

BRUISING TO BOTH EYELIDS
CORNEAL MEMBRANE OF BOTH EYES - (RED AND BLOODY)
NOSE - SWOLLEN AND BRUISED (POSSIBLY BROKEN BUT NOT CONFIRMED)
MOUTH - BRUISING TO THE LOWER JAW ON BOTH SIDES AND MIDDLE
