You are further notified that the aforementioned claimant contends that the aforementioned personal injuries
she sustained and the death of her son, EMANUEL WESLEY MURRAY, JR., were the direct and proximate result
of the negligent handling of her case by the Florida Department of Children and Families.


As a direct and proximate result of the aforementioned negligent acts of the FLORIDA DEPARTMENT
OF CHILDREN AND FAMILIES, and its employee/s, the claimant [REDACTED] was seriously
and grievously injured by Richard Anthony McTear in and about her body and extremities, suffered bodily injury
and resulting pain and suffering, disability, disfigurement, mental anguish, loss of capacity for the enjoyment of life,
expense of hospitalization, medical and nursing care and treatment, loss of earnings, loss of ability to earn money
and/or aggravation of previously existing conditions, and the pain and suffering stemming from the loss of her child.

The losses are either permanent or continuing in nature, and the claimant will suffer said losses in the future.

Further, as a direct and proximate result of the aforementioned negligent acts of the FLORIDA DEPARTMENT OF CHILDREN AND FAMILIES, and its employee/s, claimant [REDACTED] son, EMANUEL WESLEY MURRAY, JR. was murdered by Richard Anthony McTear.

There are no adjudicated penalties, fines, fees, victim restitution funds, and/or other judgments in excess of \$200.00, whether imposed by a civil, criminal, or administrative tribunal, owed by the claimant/s to the state, its agencies, officers or subdivisions.
